

Terms and Conditions of Super Gaming Bundle

- This Super Gaming Bundle ("Bundle") is offered to you by us, Hong Kong Telecommunications (HKT) Limited ("HKT"), as Extra Services of your NETVIGATOR broadband service.
- This Bundle comprises of the following designated services (collectively as "Services") and is subject to a not less than 24-month commitment period ("Bundle Commitment Period"):
 - (a) Blacknut Cloud Gaming Service, provided to you by BLACKNUT;
 - (b) Gamer Pack Service, provided to you by HKT; and
 - (c) Home Wi-Fi Service with designated Rental Router ASUS ROG Rapture GT-AX6000 ("Router") provided to you by HKT.
- 3. By subscribing to this Bundle and/or using the services under the Bundle, you confirm to have read, understood and accepted all terms and conditions in relation to the Bundle (including these Terms and Conditions), as well as the terms and conditions relating to each of the Services. - 5. These Terms and Conditions supplement and form part of your NETVIGATOR Broadband Service contract.
- 6. All fees of this Bundle will be included in your NETVIGATOR Broadband Service bills.
- 7. If you want to terminate the Bundle, you are required to give HKT not less than 30 days' prior notice as per your Bundle service contract.
- 8. Upon suspension or termination of your NETVIGATOR Broadband Service, all Services shall be suspended or terminated accordingly and any unused entitlement in relation to the Services will be forfeited without compensation in case of termination.
- 9. If you terminate any of the Services or if any of the Services is suspended or terminated for whatever reason, all other Services will be suspended / terminated (as the case may be) at the same time.
- 10. If the Bundle or any of the Services is terminated before the expiry of the Bundle Commitment Period, we will charge you early termination charges for the Bundle, which are the sum of the monthly fees for the Bundle for the remaining unexpired Bundle Commitment Period, whereby less than one month will be deemed to be one full month for calculation purpose. You may also be liable to compensate us for the value of any premium received by you or the discounted amount of any premium or product you purchased under the Bundle, if any.
- 11. At the end of the Bundle Commitment Period, if (a) HKT have not received any valid written termination request of the Bundle from you; or (b) you have not renewed your existing Bundle service contract nor entered into any new Bundle service contract with a new commitment period, the Bundle will continue to be provided to you as Extra Services of your NETVIGATOR Broadband Service under the existing Bundle service contract on a month-to-month basis, subject to you continue to be subscribed to NETVIGATOR Broadband Service and to payment of the prevailing charges of the Bundle after the Blacknut Commitment Period, until you terminate the Bundle as per the Bundle service contract.
- 12. The General Conditions of Telecommunications Service (Consumer Customers) ("General Conditions") apply (https://www.hkt.com/terms-of-use). In the event of discrepancy or inconsistency between these Terms and Conditions and the General Conditions, these Terms and Conditions shall prevail.
- 13. The Services cannot be returned, refunded, resold, transferred, exchanged for cash and/or other gifts.
- 14. To the maximum extent permitted by law, in no event will HKT be liable to you or any person for any indirect, special, incidental, exemplary, punitive or consequential damager (including loss of use, data, business or profits) arising out of or in connection with your or anyone's participation in any of the Services, whether such liability arises from any claim based upon contract, warranty, tort (including negligence), strict liability or otherwise, and whether or not you or any person has / have been advised of the possibility of such loss or damage.
- 15. We reserve the right to vary the offer of this Bundle and/or amend any terms and conditions of this Bundle (including these Terms and Conditions) at any time without notice.
- 16. In the event of dispute in relation to this Bundle, our decisions shall be final.
- 17. In the event of discrepancy or inconsistency between the English and Chinese versions of these Terms and Conditions, the English version shall prevail.
